Attending the online medical writing course knowledgeable and interesting was а conducted experience. it was in collaboration with University of Health sciences through online zoom classes and google class room for feedback and assignments so was unique in exposure and learning of the new technology along with the medical writing skills. It was CME accredited course. The content of the course covered all aspects of medical writing requirements related to of health professionals. It provided the opportunity to with from different interact persons specialties at different levels of their professional education.

New knowledge is constantly being added in medical profession with ongoing research, evolving experience, new ideas and thoughts¹. To effectively formulate the manuscript of writing different guidelines are being developed which are upgraded adherence periodically and to these guidelines is much needed practice to be adopted and learned². These guidelines are followed by the journals to select quality original articles, meta analysis, case reports, review articles and editorials and to publish them. Learning these core aspects is important as journals refuse to publish the articles that are not in accordance to the standards and guidelines.

The duration of the course was 3 months and it comprises of 6 sessions. Each session was of 3 hours. First session was conducted by Dr. Amir Furqan, cardiac anesthetist and certified CME editor. It was related to orientation of course, zoom application, concept of google classroom and designing the Topic medical research.. selection and converting it to a reasonable title is the key of an article. Study design has always been a challenge for medical professionals who were discussed according to the standards laid down and to be followed. The art of writing of original Article was discussed in detail in second session by Dr. Masood Alam. pulmonologist certified CME editor. Writing the methodology in a way to cover all the procedural points and making it easy to understand for the reader is very important aspect of an original article which was adequately elaborated. Statistical analysis again is the hardest challenge for the medical professionals and need to be learned and mastered in a way that makes it easy for them to complete their research process. That is why this course had separate session on SPSS skill training which was conducted by Dr. Lamia yousaf, gynecologist, and certified CME editor. Fourth online session was aimed at the writing of case report, book review and editorial writing which are the topics to which many of the health professionals are not very familiar .This session was conducted by Dr. Wajida rehabilitation specialist, certified CME editor and Dr. Amir Furgan. Review article including narrative, systematic review and meta analysis are the types of medical writing not commonly practiced and thought difficult to proceed with. They were taught according to the specific guidelines laid down for this subset of medical writings in 5th session conducted by Dr. Amir Furgan. Each session was followed by submission of reflection and minor assignment by all participants through google class room which were marked and

returned by the facilitators. How to submit manuscripts online and understanding of online journal management system was elaborated in 6th session by Dr. Wajida. Grand assessment system was based on minor assignments submitted following each session and major assignments submitted by the end of the course and on its bases course completion certificates were awarded to the participants.
